Please be informed that Southwest Luzon Power Generation Corporation (SLPGC), a wholly-owned subsidiary of Semirara Mining and Power Corporation (the "Corporation"), operating the 2x150MW Coal-Fired (Circulating Fluidized Bed) Thermal Power Plant located adjacent to Sem-Calaca Power Corporation's (SCPC) power plant in Calaca, Batangas has reported that Unit 1 of its 2x150MW power units (or Unit 3 of Calaca Power Plant Complex) was put down for unplanned outage since March 6, 2018, due to observed abnormal vibration of the equipment. Detailed inspection of the unit will be done immediately. While, its power unit Unit 2 (150MW) is currently undergoing regular planned maintenance outage and target unit on line is last week of March 2018.

Also, Unit 1 of Sem-Calaca Power Corporation (SCPC), another wholly-owned subsidiary of the Corporation operating the 2x300MW Coal-Fired Thermal Power Plant in Calaca, Batangas is also undergoing an unplanned outage until March 12, 2018 to give way to boiler slags removal. While, SCPC's Unit 2 is also currently undergoing a planned outage, to include the thorough assessment/inspection of the unit prior to the final phase of the rehabilitation (life extension program) in 2019. Unit 2 is expected to be back online by end of the month.

Both SLPGC and SCPC has still allowable outage, hence, not incurring any replacement power.
